



LOCAL HOST ORGANIZATION AGREEMENT

I, _____, have the authority to represent _____, (hereafter known as the Local Host Organization) hereby acknowledge that in exchange for the right to be the official Local Host Organization in _____ (city or region) to host/co-host the **7DAYPSA**, a national public service announcement (PSA) competition being produced by the Rhode Island International Film Festival (RIIFF) as a Creative Impulse Award Competition, the Local Host Organization agrees to follow all rules and regulations set forth by the **7DAYPSA** (available on the official **7DAYPSA** web site). The Local Host Organization will not hold the **7DAYPSA**, the Creative Impulse Awards, RIIFF or any related parties liable for events arising from the hosting of a local **7DAYPSA** competition. The Local Host organization will produce their event between ____ / ____ / 2010 and ____ / ____ / 2010.

The local host organization has read, acknowledged and agrees to all the rules, regulations and release of obligations for the **7DAYPSA** competition (available on the competition's official web site).

The Local Host Organization is responsible for producing an event that reflects the high standards of the **7DAYPSA**, the Creative Impulse Awards, and the Rhode Island International Film Festival.

The Local Host Organization has the right to use the **7DAYPSA** name and logo in a responsible manner on their website, press releases, posters, fliers, etc.

In addition, the Local Host Organization is responsible for:

- 1) All costs related to the producing the local competition.
- 2) Collection of all entry fees.
- 3) Proper record keeping.
- 4) Securing local media sponsors.
- 5) Securing local non-profit "client" organizations.

6) Securing other local sponsors and event venues.

The Local Host Organization will, in a timely manner, turn over to the **7DAYPSA**:

- 1) Copies of all requested records related to the local competition.
- 2) Broadcast quality DVD copies of the winning PSA's.
- 3) \$20.00 of every \$120.00 "Agency" team entry fee.

The **7DAYPSA** will provide:

- 1) Guidance and assistance.
- 2) Master copies of all forms, contract, agreements, and releases to be used by the Local Host Organization.
- 3) Inclusion on the official **7DAYPSA** web site with a link to the Local Host Organization's web site.
- 4) Inclusion of the Local Host Organization in our national press efforts.
- 5) Availability of national **7DAYPSA** officials to talk to local press/media.
- 6) Entry of the local winning PSA in the national **7DAYPSA** competition.
- 7) Consideration for application of local winning PSA's in industry sponsored award competitions. (*examples: Emmy Awards, Telly Awards, etc.*)

The **7DAYPSA** reserves the right to revoke the Local Host Organization's right to host an official **7DAYPSA** competition at any time for failure to comply with the terms of this agreement.
